### ***DIRECTIONS to the ODTCW, 11 Robinson Lane Oxford, CT 06478 Phone: 203-888-9156***

*Take I-84 East or West to Exit 16. At end of ramp, turn Left onto Rt. 188 South. Go Approximately 1 mile and turn left onto Airport Rd. Continue straight about ¾ mile and turn right onto Christian St. (2nd right off Airport Rd.) stay on Christian St. for approx. 1 mile to Robinson Lane (4th right) between Ma's Mini-Storage and Joyce Trucking. Turn on to Robinson Lane. The training facility is .1 mile on the left in the back of the building.*

*Rte 8 South or Rte 63 to I-84 and proceed as above.*

*Rte 8 North to exit 22 (Bank Street) Left off exit. Left onto Route 67. Proceed on Rt. 67 for 5 miles. Turn right onto Christian St. for 1.5 miles. Turn left on to Robinson Lane and proceed as above.*
